Enrolling in the Certificate IV in Work Health and Safety you will develop the knowledge and skills to apply Safety and Health legislation in the workplace.

This course teaches the individual relevant skills how to be a meaningful Safety Officer, to provide safety leadership, and have some responsibility for the output of others and also provide guidance to others.
